APPLICATION FOR UTILITY TAP SERVICE

This application is for new construction or first time connection to the Town of Bolon water and sewer service. The Town of Bolton provides in-town and out-of- town (when financially feasible) water and sewer service.

For new construction, a driveway must be installed on the property before the Town will provide the taps for water and sewer. The Town will not install access without the driveway. The Town requires the following fees:

In-town limits:

Water Tap Fee \$700
Sewer Tap Fee \$1,000

Out-of-town limits:

Water Tap Fee \$800
Sewer Tap Fee \$1,000

These fees are initial deposits as there may be additional costs based on actual cost to the Town of connection. Costs will be determined by the average hourly salary of the maintenance crew along with the costs of pipe, meter boxes, and other supplies necessary to make the tap. Equipment charges will be based on the current FEMA schedule of rates. A Town representative will visit the site and prepare an expected cost quote.
